#### 1. Course description

##### 1.1. Course objectives

The course aims to familiarize students with the specifics of forensic and penal population and the possibilities of treatment in compulsory treatment conditions. The students shall be familiarized with the basic legal regulations related to the sanctions as ordered by the court as well as with the provisions of that part of Mental Health Law which refers to mentally incompetent persons. The models of managing the system which contains orders of compulsory detention and treatment are very complex and harmonized with the international conventions and human rights laws. The necessary ethical, legal and methodological principles and algorithms of treatment shall be presented, as well as mechanisms of risk assessment and risk management in the Republic of Croatia and abroad.

The students are expected to gain knowledge of the legal provisions related to human rights, patient rights, rights of the mentally ill, prisoner rights and the Mental Health Law. The students must know the basic models and therapy programs of dealing with the above named population.
